East Rock Creek Village (ERCV) is a nonprofit, volunteer-driven membership organization committed to providing services and social activities to help seniors thrive while living in their own homes as long as possible. ERCV membership is open to residents 50+ years living in Brightwood, Colonial Village, Crestwood, Manor Park, North Portal Estates, Shepherd Park, and Takoma, DC.

ERCV OFFERS THREE TYPES OF MEMBERSHIP:

SERVICE MEMBERSHIP

If you join as a Service Member (individual or household), you are eligible for services such as rides to medical appointments, small household chores, shopping and other similar tasks, and you can attend all programs – social and educational – that ERCV presents throughout the year. Your membership fee is not tax-deductible.

SUSTAINING AND BASIC SOCIAL MEMBERSHIPS

If you join as a Sustaining or Basic Social Member, you can attend all programs – social and educational – that ERCV presents throughout the year. A Sustaining Member may convert to Service Membership without paying any additional amount for the balance of the membership year.

If you wish to convert a Basic Social Membership to a Service Membership, you must pay a pro-rated difference between the \$200/\$300 and \$500/\$750 annual fees for the remainder of your membership year. You should consult with your tax professional about deductibility. Otherwise, as a Basic Social Member you are entitled to all other benefits of Social Membership.
